

2017 - 2018 BILLS OF INTEREST TO SCICU

The 2017 Session (1st regular session) of the 122nd South Carolina General Assembly convened on January 10, 2017 and is scheduled to end sine die on May 11, 2017. Bills introduced during the 1st session will be carried over to the 2nd session which begins January 9, 2018 and is scheduled to end on sine die May 10, 2018.
